

SELF-MONITORED

When self-monitored the K.I.T Personal Safety Device will call the nominated contact when an emergency alert is triggered, allowing that person to speak directly to the wearer.

How does it work?

The K.I.T Personal Safety Device will be programmed to call a nominated contact, as well as send an alert to up to five authorised family members or friends via SMS and/or email, providing them the last known GPS location of the unit.

You may also call the device to speak to the wearer via the two-way audio function.

If set up as an administrator, you can login to the K.I.T web based Online client Console at any time using your user name and password. This will allow you to securely monitor the wearer's location or alter the settings to customise the device to the needs of the wearer.

24/7 MONITORED

Your K.I.T Personal Safety Device can also be monitored by a 24-hour monitoring centre for dedicated support and response.

How does it work?

When an alert is activated the staff at the monitoring centre will listen in to what is occurring and provide assurance to the wearer via the handsfree function of the device while viewing the persons location. They will then respond based upon the wearers needs (e.g. police or ambulance) as well as notify nominated persons, such as co-workers, managers, etc.

For those persons working in areas of greater personal threat, there is also the option for the device to operate in security mode. This permits discrete activation of an alert together with one-way audio only, allowing the monitoring staff to listen to what is occurring but not talk with the wearer so as to not escalate the situation.

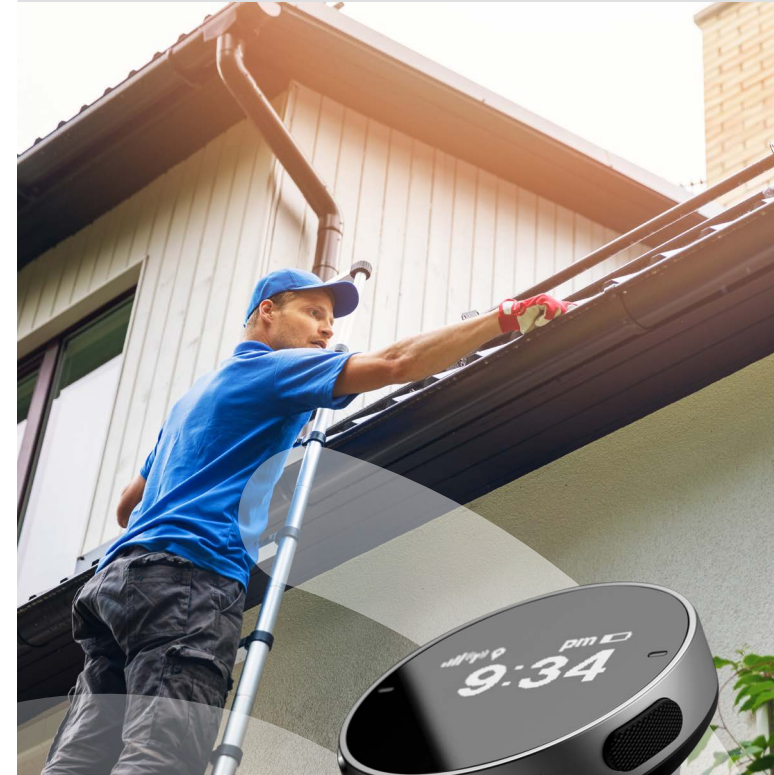

LONE WORKER MOBILE PERSONAL SAFETY DEVICE

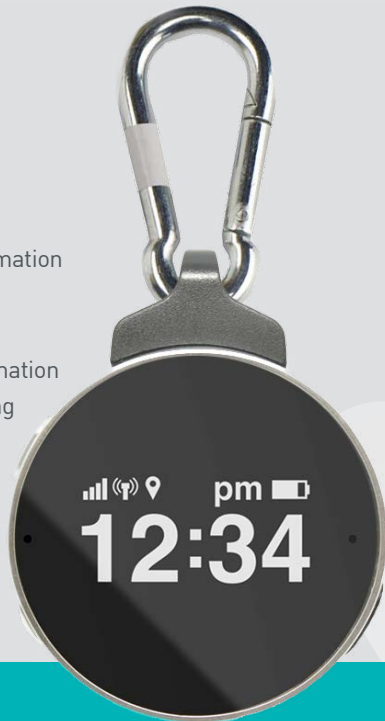
The K.I.T Personal Safety Device is both compact and easy to use, with onboard GPS and mobile connectivity, together with two-way voice communication.

Alerts can be self-monitored via the K.I.T Online Console or fully monitored via a 24/7 response centre.

With no complicated touch-screens or set-ups, the K.I.T Personal Safety Device uses its own SIM card, allowing it to connect to the mobile network, without the need for a separate mobile phone. This ensures the device is the easiest solution to use for the wearer, providing them security and peace of mind at any time.

MOBILE PHONE FUNCTION

The K.I.T Personal Safety Device has its own SIM card and works like a mobile phone. It can call two pre-programmed numbers, as well as the pre-set emergency or monitoring number. You can also call the device from any phone (unless access is restricted to nominated callers).



SOS ALERT

Press the black SOS button for two seconds and your K.I.T will connect you via a two-way handsfree phone call to your pre-set SOS number or a 24/7 monitoring centre and send your location via SMS and/or email to your emergency contacts.



GEO-FENCE

If you would like the extra safety of being notified when the wearer leaves an area by setting up a geo-fence you create a 'safe zone'. Safe zone alerts can notify authorised contacts via SMS and/or email. The geo-fence can be set as a radius from an address and an alert will be triggered if the wearer is located outside of that zone.



MAN DOWN

With a built-in accelerometer and impact sensor, the K.I.T Personal Safety Device will call your nominated emergency number and alert your authorised contacts via SMS and/or email in the event of an accidental fall.



VIBRATION CONFIRMATION

With on-board vibration, the K.I.T Personal Safety Device can provide discrete confirmation that an SOS alarm has been sent or that a man-down alert has been activated.



WEB INTERFACE

Our easy-to-use web interface allows access to the K.I.T map screen together with the management of device features and functions via the Online Client Console.



24/7 MONITORING CENTRE

Your K.I.T Personal Safety Device can be monitored by a 24-hour monitoring centre for dedicated support and response.



NON MOVEMENT ALERT

This can be set to provide an alert after a pre-determined time if there is absolutely no movement detected from the device (excluding when on charge).



EASY CHARGING

The K.I.T device includes a rechargeable battery and an easy-to-use, charger. The magnetised design ensures the device connects the right way.



CHECK-IN / CHECK-OUT

This is a timer countdown that can be set to provide additional verification in situations where it might not be possible to manually trigger an alert. These can be easily configured via the On-line console.



WATER RESISTANT

With IP67 rating the K.I.T Mobile Personal Safety Device can be worn in the shower or in the rain.



WEARABILITY

K.I.T is compact and lightweight (weighing just 51 grams) and can be worn as a watch, attached to a lanyard or on a carabiner.
